RULES AND REGULATIONS

1. Official crop data cards may be obtained from the sponsors of the Champion Market Wheat Show. Official crop data cards must be completed prior to entry.
2. Entry shall be accompanied with the completed official crop data card on reverse side.
3. **ENTRY DATE: 3:00 P.M. TO 5:00 P.M. ON SUNDAY, BEFORE THE FAIR AND 8:00 A.M. TO 5:00 P.M ON MONDAY OF THE FAIR**
4. All wheat exhibits shall be produced during the current year.
5. All exhibits shall be of COMBINE RUNS ONLY. Sample shall consist of a **5 gallon bucket of wheat**. One gallon of this wheat will be exhibited, remainder will be used for the judging.
6. ANY ENTRY WHICH HAS BEEN HAND-PICKED AND/OR SCREENED WILL BE DISQUALIFIED.
7. Limitation of entries Each farmer (of farm) is limited to TWO entry for each lot, providing that variety is grown on exhibitor's farm. Landlord may enter if tenant does not.
8. Decision of the judges will be final; no appeals will be considered.
9. In case of a tie; premiums will be added together and divided by the number of entrants tying.
10. All exhibits of wheat become to property of the Champion Market Wheat Show.
11. Overall Champion wheat exhibit will receive a Sweepstake Award.
12. Samples will be judged by the following criteria:
 - Variety/Mill-Bake.....250
 - Protein.....225
 - Test Weight.....200
 - Dockage200
 - Shrunken and broken.....100
 - Completeness of official crop data card...25



Entries that score high (approximately 25%) will be taken to the State Fair.
